Order

Kudumbashree is the Nodal Agency for Implementation of National Urban Livelihoods Mission in Kerala. Mission intends to impart placement linked skill training to large number of unemployed youth in the state under the component Employment through Skill training and placement (ESTP). Execution of this component requires the service of the Skill Training Providers. As per reference cited as 1& 2 above State Urban Livelihoods Mission can directly enter into agreement with Government institutes, Training partners of National Skill Development Corporation, ITIs, Polytechnic colleges technical universities, training providers engaged by any other Government agency for the purpose of Skill training etc.

In these circumstances sanction is hereby accorded to empanel and directly avail the service of the training agencies under the following category, so as to avail their service for EST&P Component of NULM in the state.

1. NSDC partners
2. Training Agencies empanelled by Kudumbashree in the category of 'Excellent' and 'Good'
3. Agencies engaged by Kudumbashree under DDUGKY.
4. State Government agencies.

State Mission Management Unit may invite the willingness of the training agencies along with the credentials to prove their eligibility under the above category to works as the skill training providers for NULM. These agencies can directly submit their willingness to SULM. The empanelled agencies will submit their proposal for conduct of skill training and placement in specific job roles with all details like curriculum, certification arrangements, infrastructure of the available or proposed training centre, profile of the trainers, placement offers etc. State Urban Livelihood Mission (SULM) may enter into agreement with these agencies after detailed appraisal of the proposal submitted by them. Proposal will be appraised on the basis of available/proposed infrastructure of the training centre, track record of the agency in

training & placement in this job role, Status of placement partners, qualification of trainers, initial salary in the placement offer etc.

Further there are competent training agencies and industrial houses/Industrial associations having potential for in-house placement of trained beneficiaries within and outside the state, though they are not eligible for direct empanelment as per aforesaid criteria. Therefore to enlarge the pool of training providers and placement opportunities more agencies needs to be empanelled through a competitive selection process. Accordingly sanction is accorded to invite EoI from such agencies.
