Action taken report on previous meeting minutes

- ✓ Completed street vendor survey in all 93 ULBs
- ✓ Conducted three regional orientation workshop to sensitize elected representatives as well as corporation / municipal employees on Street Vendors (protection of livelihoods and regulation of street vending) Act- 2014.
- ✓ Draft (modified) state rules & schemes under 'the Act' submitted to the government viz letter No. 4596/F/2012/KSHO dated 21/10/2016.
- ✓ Circular issued to all ULBs viz no 4569/F/2012/KSHO dated 28/10/2016 to cover all urban street vendors through survey and to issue ID cards and license.

Key Achievements under NULM

- ✓ Street vendor survey completed in 93 Urban cities.
- ✓ Identified 19863 street vendors
- ✓ ID card issued to 1117 street vendors in 4 ULBs
(Malappuram-92, Thrissur- 472, Palakkad- 503 & Chavakkad -50)
- ✓ Town Vending Committee Constituted in 76 ULBs
- ✓ District Level Advisory Committee constituted in 8 Districts
