**ORDER**

The Government of India launched Pradhan Mantri Awas Yojana (PMAY) with the mandate of providing "Housing for All" by 2022. From the State of Kerala, 15 cities/towns had been selected under the scheme in the first phase.

2. As per the mission guidelines, two committees are to be constituted at the state level, viz., the State Level Sanctioning and Monitoring Committee (SLSMC) and State Level Appraisal Committee (SLAC). Apart from the above two, the State Level Nodal Agency for the implementation of the scheme, i.e., Kudumbashree; as per the the letter read above, proposed to constitute a State Level Advisory Committee with Minister (Urban Affairs) as Chairman to review and evolve policies to guide the implementation of the scheme. On the basis of the decisions taken by Urban Housing Mission Governing Body held on 21.10.2015, it was also proposed to constitute a Reforms Committee.

3. Government have examined the matter in detail and are pleased to constitute the following committees for the effective implementation of the Pradhan Mantri Awas Yojana (PMAY) in the state:

- v) Reviewing progress of approved projects in the State
- vi) Monitoring of implementation of the Mission
- vii) Any other issues required for implementation of the Mission.


